INSTITUTIONAL DECLARATION BEFORE the ATTACK OF ETA

5 of january 2007

THIS IT IS NOT THE WAY, LEAVES EUSKAL HERRIA PEACEFULLY!

2006, the year that was going to happen to our history, have left in its last days a lamentable fact us, but from UDALBILTZA® we will continue crossing the way of La Paz. The main consequences of the rupture of the cease-fire are the following ones:

1. The resignation to the trajectory raised by Batasuna in Anoeta, the resignation therefore to the political routes.

2. The conclusion of the process of peace and political normalization, by express decision of ETA and the return of the fear and the violence to our country.

In this context, Udalbiltza® defends the right to live peacefully and to decide that it has the Basque town, and as well as it has defended it in the past will continue it defending in the future.
